ACCOUNT AGREEMENT TERMS AND CONDITIONS

SUN STATE INTERNATIONAL (SUN STATE) abides by all the federal credit laws: Fair Credit Reporting Act, Equal Credit Opportunity Act, Fair Credit Billing Act and Fair Debt Collection Practices Act.

The authorizing signatory represents that he/she has the authority to execute this Credit Application and Account Agreement and in doing so causes company to be bound hereby and agrees:

1. **USE OF ACCOUNT:** Account holder will be responsible for all credit extended by SUN STATE in connection with this open credit account and hereby authorizes SUN STATE to provide goods and services with or without signed invoices.

2. **ACCOUNT HOLDERS RESPONSIBILITY:** Account holder agrees to be responsible for and to pay for all products sold to account holder on Net 30 Day Terms. In addition, account holder agrees to pay a finance charge on delinquent accounts in the amount of 1.5% per month (18% APR). SUN STATE may revoke account holders credit or place delinquent accounts on COD and reserves the right to close this account whenever they deem necessary.

Account holder understands and agrees to permit SUN STATE to conduct and investigate report and to obtain information regarding account holder's credit. Account holder hereby authorizes SUN STATE to contact third parties to obtain financial information regarding the account holder's credit capacity, general credit reputation, character and such other and further information as deemed necessary.

Account holder agrees to notify SUN STATE within 60 days of receipt of any disputed charges and to work together with SUN STATE to resolve any billing discrepancies or disputes; failure to do so, obligates the account holder to pay the amount set forth in the statement in full.

All accounts will be considered taxable until a copy of your Consumer's Exemption Certificate or Resale Certificate is provided. Each January 1st your account will return to taxable until your new certificate is provided.

3. **DEFAULT:** On any default or failure to pay, SUN STATE may declare any unpaid balances immediately due and payable. In addition, account holder agrees to pay all costs of collection including but not limited to the prejudgment interest, attorney's fees, and court costs. Venue will be at the sole discretion of SUN STATE.

4. **RETURNED CHECKS:** Pursuant to the Florida Statute 68.065, a returned check fee will be charged for all returned checks.

5. **ENFORCEMENT:** This agreement is binding on the account holder, the account holder's heirs if any, representatives, successors in interest, and assigns. In addition, account holder will inform SUN STATE, in writing, of any changes in company ownership, name, structure and or officers, members and/or principals.
